

## Stay at Home, Work from Home – List of workers deemed essential

Release Date: March 24, 2020

On March 23, Hawaii's Governor David Ige issued a statewide stay-at-home order to help fight the spread of COVID-19. The order goes into effect at 12:01am on Wednesday, March 25, 2020 and extends through April 30, 2020. Essential workers are exempt.

Looking for guidance on whether your work is essential or you need to stay home? Employees who are considered "essential workers" are expected to report to work and are allowed to be traveling to and from work. Businesses with essential workers are allowed to remain open to be able to provide these essential services to our local community. These businesses should continue to enact social distancing and appropriate disinfection and cleaning procedures. Businesses with non-essential workers are expected to close or allow employees to work from home. Employees whose work is non-essential are not supposed to be traveling to and from work.
